

ADR and DGSA COURSES

Drivers of **all** vehicles carrying dangerous goods in scope of the regulations after 1 January 2011 must be trained and hold a vocational training certificate issued by DVLA. This is required by UK regulations implementing the relevant EU directives. There are no 'grandfather rights'.

Compulsory refresher training must be completed within the five-year validity period of the certificate. Candidates should be entered on courses at least 12 weeks before expiry of a current certificate to minimise risk of a gap in continuity.

The maximum number of delegates per course is 20. Courses may be held at your own premises, subject to size & suitability (please phone for a quote).

In addition, the regulations state that drivers carrying limited quantities, and **any staff involved** in the handling or movement of Hazardous materials, are required to have Hazard Awareness Training.
